

RESOLUTION NO. 44460

A resolution providing for canvassing the returns and declaring the result of the special election held in the Parish of East Baton Rouge, State of Louisiana, on Saturday, October 15, 2005, authorizing the extension of the levy and collection of a one-half of one percent ($\frac{1}{2}\%$) sales and use tax therein for an additional twenty-three (23) years for the purpose of providing funds (1) for construction of new roads in the Parish, and (2) for road rehabilitation and beautification projects, and to authorize the funding of the proceeds of said tax into bonds; and providing for other matters in connection therewith.

BE IT RESOLVED by the Metropolitan Council of the Parish of East Baton Rouge and City of Baton Rouge (the "Metropolitan Council"), acting as the governing authority of the Parish of East Baton Rouge, State of Louisiana:

SECTION 1. That this Metropolitan Council does now proceed in open and public session to open the envelope containing the official tabulations of votes cast at the special election held in the Parish of East Baton Rouge, State of Louisiana (the "Parish"), on Saturday, October 15, 2005, to authorize the of the levy and collection of a one-half of one percent ($\frac{1}{2}\%$) sales and use tax therein for an additional twenty-three (23) years for the purpose of providing funds (1) for construction of new roads in the Parish, and (2) for road rehabilitation and beautification projects, and to authorize the funding of the proceeds of said tax into bonds, said tabulations having been prepared and certified by the East Baton Rouge Parish Clerk of Court, and this Metropolitan Council does now further proceed to examine, count and tabulate such votes and to examine and canvass the returns and declare the result of the special election.

SECTION 2. That a Proces Verbal of the canvass of the returns of said election shall be made and that a certified copy thereof shall be forwarded to the Secretary of State, Baton Rouge, Louisiana, who shall record the same in his office; that another certified copy thereof shall be forwarded to the Clerk of Court and Ex-Officio Recorder of Mortgages in and for the Parish of East Baton Rouge, who shall record the same in the Mortgage Records of the Parish; and that another copy thereof shall be retained in the archives of the Metropolitan Council.

SECTION 3. That the results of said election shall be promulgated by publication in the manner provided by law.

PROCES VERBAL AND PROCLAMATION OF THE CANVASS OF THE VOTES CAST AT THE SPECIAL ELECTION HELD IN THE PARISH OF EAST BATON ROUGE, STATE OF LOUISIANA, ON SATURDAY, OCTOBER 15, 2005.

BE IT KNOWN AND REMEMBERED that on Wednesday, October 26, 2005, at four (4:00) o'clock p.m., at the Council Chambers, Parish Governmental Building, Third Floor, Room 348, 222 St. Louis Street, Baton Rouge, Louisiana, its regular meeting place, the Metropolitan Council of the Parish of East Baton Rouge and City of Baton Rouge, acting as the governing authority of the Parish of East Baton Rouge, State of Louisiana (the "Parish"), and being the authority ordering the special election held in the Parish, on Saturday, October 15, 2005, with the following members present:

did, in open and public session, open the envelope containing the official tabulations of votes cast at the said election as prepared and certified by the East Baton Rouge Parish Clerk of Court, and did examine, count and tabulate such votes, and did examine and canvass the returns of the said election, there having been submitted at said election the following proposition, to-wit:

PROPOSITION

SUMMARY: AUTHORITY FOR THE PARISH OF EAST BATON ROUGE (THE "PARISH") TO EXTEND THE LEVY AND COLLECTION OF THE ½% SALES TAX PRESENTLY AUTHORIZED TO BE LEVIED PURSUANT TO AN ELECTION HELD ON NOVEMBER 17, 2001, FOR AN ADDITIONAL TWENTY-THREE (23) YEARS FOR THE PURPOSE OF PROVIDING FUNDS (1) FOR CONSTRUCTION OF NEW ROADS IN THE PARISH, AND (2) FOR ROAD REHABILITATION AND BEAUTIFICATION PROJECTS, AND TO AUTHORIZE THE FUNDING OF THE PROCEEDS OF SAID TAX INTO BONDS.

Shall the Parish of East Baton Rouge (the "Parish"), under the provisions of Act 639 of the 1984 Regular Session of the Louisiana Legislature, and other constitutional authority, be authorized, effective January 1, 2006, to extend the levy and collection of the ½% sales and use tax presently authorized to be levied by the Parish through December 31, 2007, pursuant to an election held on November 17, 2001 (the "Tax"), for an additional twenty-three (23) years, and shall the proceeds of said Tax be used entirely and exclusively (1) to provide funds (70% of the proceeds of the Tax) (a) for

the widening of existing public roads and streets, and/or (b) the construction of new public roads and streets, such projects within the City of Baton Rouge and the Parish on a priority basis as described in the Transportation and Street Improvements Program dated June 8, 2005, and such projects within the City of Baker, the City of Zachary and the City of Central, on a priority basis as determined by the respective governing authority of such incorporated municipality, and (2) (a) to provide funds (27% of the proceeds of the Tax) for the repair and improvement of public roads and streets, including engineering services, drainage and traffic signal synchronization, and (b) to provide funds (3% of the proceeds of the Tax) for road beautification projects, including landscaping and sidewalks and the maintenance thereof, all on a priority basis, within the Parish, the City of Baton Rouge, the City of Baker, the City of Zachary and the City of Central; and shall the Parish be further authorized to fund proceeds of the Tax into bonds from time to time for any one or more of the aforesaid capital purposes set forth in clause (1) above, to the extent and in the manner permitted by the laws of Louisiana?
